- 1 L BestSolv[™] 7100 or BestSolv[™] Sierra

- 2. DFO with BestSolv™ Sierra and BestSolv™ Delta
 - 0.25 g DFO Powder
 - 30 ml Methanol
 - 20 ml Acetic Acid
 - 275 ml BestSolv™ Delta
 - 725 ml BestSolv™ Sierra
